

1. Govt has decided that medical examination of candidates seeking admission in class- IV for the session 2020-21 be got done by the Chief Medical Officer (CMO) of the concerned district to which the candidate belongs. This has been done keeping in view the pandemic COVID-19
2. Since your ward is placed in the merit list, you are, therefore, requested to get him/her medically examined by the CMO and submit the medical fitness certificate as per performa (copy enclosed) to this office so that further action for admission of your ward in class-IV for the session 2020-21 be taken.
3. The admission so given will be provisional and subject to the following two issues, which will be on physical joining of your ward in the school:-
  - (a) Final verification that the child being given admission in the school is the same who passed the tests (PESAT & written).
  - (b) Age verification
4. On the confirmation of the above, the admission will be considered final.

A medical examination of the candidates who make it to the merit list of Physical Efficiency & Sports Aptitude Test and get qualifying marks in the Written Test will be medically examined by a Medical Board consisting of the following doctors:-

1. Specialist of Paediatrics
2. Specialist of ENT
3. Specialist of Ophthalmologist
4. Specialist of General Surgery
5. In charge, Infirmary, Motilal Nehru School of Sports, Rai

The medical examination will be carried out according to the standard mentioned below:-

1. The medical examination of candidate for admission to the school will be carried out by a Medical Board at Rai or any other place decided by the Principal & Director, Motilal Nehru School of Sports, Rai. It will be carried out according to the following standards:-

A. The minimum acceptable visual standards will be as under:-

a) Distant Vision	6/12	6/12		6/6

The power of the Glasses should not exceed +4.50 D, which include spherical and cylindrical combined together.

- b) Colour vision :-The candidate should be able to identify clearly both red and green colours.
- c) Field of Vision:- Normal in each eye as tested by confrontation method.
- d) Binocular Vision:- Candidate must have complete Binocular vision.
- e) There is no squint or morbid condition of the eye or the lids which is liable to risk of aggravation of recurrence.
- f) There is no active trachoma or its complications and squalae.

B. It will also be ensured that:-

- a) There is no evidence of weak constitution, imperfect development, serious malformation or obesity.
- b) There is no mal-development or impairment of function of the bones or joints.
- c) There is no major impediment of speech.
- d) There is no impaired hearing, discharge from or disease of either ear, unhealed perforation of the tympanic membranes or signs of acute or chronic suppurative otitis media or evidence of radical or/modified radical mastoid operation and that the children having such conditions should be reviewed after treatment and thereafter declared fit or unfit as the case may be.
- e) There is no gross degree of disease of the bones or cartilage of the nose or usual polypus or disease of the nasopharynx and accessory sinuses. Such cases can be reviewed after treatment.
- f) There is no generalised lymphadenopathy and the thyroid gland is normal.
- g) There is no evidence of pulmonary tuberculosis elsewhere in the body.
- h) There is no sign of organic disease of the heart and blood vessels.
- i) There is no evidence of any disease of the digestive system including any abnormality of the liver and the spleen. There is no evidence of any metabolic disorder.
- j) There is no hernia or tendency thereto. This is subject to treatment.
- k) There is no hydrocele or definite varicocele or any other disease or defect of the genital organs. This is subject to treatment.
- l) There is no fistula and/or fissure of the anus or evidence of haemorrhoids, That the children having such conditions should be reviewed after treatment and thereafter declared fit or unfit as the case may be.
- m) There is no disease of the Kidneys.
- n) There is no disease of the skin unless temporary or trivial. Scars which by their extent or position cause or are likely to cause disability or marked disfigurement are a cause for rejection.
- o) There is no active, latent or congenital venereal disease
- p) There is no evidence of mental disease, Candidate suffering from epilepsy, incontinence of urine or enuresis will not be accepted.
- q) There are no flat feet or knock knees of significant nature which might interfere in the sports activity of the students.
- r) The medical board can out rightly disqualify a candidate whose apparent age and physical growth seems to be higher/lower than his/her recorded age.

The final merit list of admission will be prepared on the merit list of Physical Efficiency & Sports Aptitude Test with qualifying marks in Written Test, result of Medical Test and considering the Reservation Policy of the Govt. of Haryana.
