TERMS AND CONDITIONS FOR SUPPLY OF ICE CREAM THE YEAR 2022-23.

- School remains closed twice in the year i.e. summer and winter vacations in the month of May/June, Dec/Jan of every year respectively. There may be other breaks such as Diwali break etc. Ice cream may not be required during breaks. However in case of the requirements the same will have to be supplied by the contractor.
- 2. In case of any emergency if school is closed, the balance items will be returned back with immediate effect.
- 3. Timing of supply of ice cream as per requirement of school mess.
- 4. Quantity of ice cream will be decreased or increased as per daily requirement.
- 5. Supply of ice cream will be on F.O.R (Freight on Road) basis to MNSS Rai.
- 6. In case the ice cream is not supplied in time (as specified by the school) or found substandard, the payment of ice cream will not be made of that particular day.
