TERMS AND CONDITIONS OF SUPPLY OF SWEETS AND PANEER CONTRACT

1. The period of contract will be up to 31st May 2024.
2. The contractor has to deposit a sum of Rs. 20,000/- as security money in the School office which shall be refunded on completion of the contract. The security money will be forfeited in case of termination of the contract.
3. In case the quality of sweets and paneer is found of substandard/ inferior quality or if not as per govt. standards at anytime, it will be rejected at the firms cost and payment of bill will not be made. The security money deposited with the school will be forfeited.
4. The school remains closed twice in a year i.e. in summer and winter vacations in the month of May-June and Dec-Jan of every year respectively. There may be other breaks such as Diwali breaks etc. above items may not be supplied by the contractor.
5. An Agreement on stamp paper of Rs. 100/- will be submitted in the office which will be signed by both the parties.
6. In case of any dispute the jurisdiction will be sonipat court only.
7. The contract can be terminated at any time without assigning any reason by Director & Principal MNSS Rai in case of work not found satisfactory.
