**AGREEMENT FORM TO BE EXECUTED BY FATHER/GUARDIAN OF STUDENT OF  
MOTILAL NEHRU SCHOOL OF SPORTS, RAI – 131029, DISTT. SONIPAT (HARYANA)**

This agreement made this \_\_\_\_\_ day of \_\_\_\_\_  
between \_\_\_\_\_ (hereinafter called the Guarantor which expression shall, unless  
executors, administrators and legal representative) of the one part and the Government of Haryana (hereinafter  
called the ‘Governor’ which expression shall unless; excluded by the context be deemed to include its  
successors and assignees of the other part.

Whereas \_\_\_\_\_ (School No. \_\_\_\_\_) son/daughter  
of \_\_\_\_\_ (hereinafter called the student) is son/daughter/ward of the guarantor and  
has at the request of the guarantor been selected for admission to Motilal Nehru School of Sports, Rai, interalia,  
on the terms and conditions hereinafter appearing for the purpose of receiving education upto Senior School  
Certificate Examination, or any other examination that the Government may prescribe (with special emphasis  
on sports and games) with a view to choosing his/her own profession in life.

Now, it is hereby agreed by and between the parties hereto as follows:-

- (1) That in consideration of the student’s being admitted by the Government to the Motilal Nehru School of Sports, Rai for the purpose of the aforesaid education at the request of the guarantor, the guarantor convenient with the Government that the student will attend the Sports School regularly and will observe and comply with all the rules and regulations thereof for the prescribed period until he/she is declared fit for admission to any institution as may, from time to time, be approved by the Government and that he/she, the guarantor, shall pay to the Government regularly and promptly and whenever called upon to do so, all the fees and dues as prescribed and fixed from time to time and demanded.
- (2) That if, after admission, any of the following, viz. proof of domicile, certificate of age, school leaving certificate, medical certificate and statement of income supplied by the guarantor is found to be false in any way or not in order, the student shall be discharged forthwith and seat offered to another deserving child.
- (3) That if, after admission, the student is found to be medically unfit in any way at any time, which might according to the opinion of the appropriate medical authorities render him/her unfit for pursuing his/her training at the School, the student will be withdrawn at once. Those students who had chronic diseases as specified by the School administration prior to the admission and concealed by the parent will also be withdrawn as and when such disease comes to the notice of school administration.

(4) That the Government will not be liable for any damages/charges on account of injuries fatal or otherwise, which may be sustained by the student at any time during his/her stay in the school while taking part in sports, extra curricular or any other activities in school or abnormal Behaviour or his/her contracting any illness/disease within or outside the school premises. All expenses that may be incurred on the treatment of such injuries will be borne by the guarantor and responsibility for care of the child during his/her treatment outside school premises will also be that of the guarantor.

(5) That the progress of the child will be reviewed at the end of every academic year i.e. in March, and if the child is not showing the desired progress in sports and/or studies, the entire amount of rebate granted to him/her in terms of school fee shall be reduced or even totally withdrawn. A similar action shall be taken if in the opinion of the school authorities, the behaviour and or conduct of the child has not been satisfactory.

(6) That if the student runs away from the school/leaves the school premises without prior written permission of the school authorities, the school shall not in any way be responsible for his/her safety and/or security. The decision of the school authorities in such an eventuality, whether to retain the child in the school or not, keeping in view the larger interest of the other students and also the school discipline, shall be final.

(7) That the guarantor solemnly undertakes to pay the school fee & other charges as in force at the time of admission and as revised by the Government from time to time in future.

(8) That the Principal & Director can in the interest of the school have the student removed if in his opinion the student has failed to accept the discipline of the school and his/her continued presence is considered detrimental to the interests of the other students and/or the student fails to come up to the academic, sports or athletic standards of his/her class and when detention in the same class would make the student a misfit among his/her classmates. In case his ward absents from the school for more than 15 days without proper sanctioned leave his/her name shall be deemed struck off from the school Rolls.

(9) That the guarantor shall, whenever, the school closes on account of vacation/mid term break, etc. personally come to the school to collect/escort his/her ward or depute any other person with a letter of authority to do so on his/her behalf, as and when directed by the school authorities. If no one reports in the school according to the announced schedule, the boys of classes VIII and above will be sent home unescorted at the risk and responsibility solely of the guarantor. In case of all girl students and boys upto classes VII, the school may very sparingly provide escort or allow the student to stay back on full cost of the guarantor.

(10) That if the student fails to pass the annual examination or avoids taking the examination on flimsy grounds, he/she shall be detained in the same class and the entire scholarship/concession/rebate granted to him/her shall be withdrawn forthwith. The school authorities reserve the right to discharge the student in such an eventuality even if the guarantor may be willing to pay the full fee.

(11) That if there is any dispute as to the effect or the meaning of these presents or in any way touching or arising out of these presents the same shall be referred to the sole arbitration of the Additional Chief Secretary to Government of Haryana, Sports & Youth Affairs Department whose decision shall be final; and

(12) That the stamp duty on this agreement shall be borne by the guarantor.
